Glenfield Borough Council Meeting

June 17, 2027

The Glenfield Borough Council Meeting was brought to order by President Paul Carmody at 7:00 p.m. with the salute to the flag. Roll was called and present were Paul Carmody, Megan Larkin, Joel Kaminski, Greg Joyce, Sam McGee, Travis Hartzog, Curtis Reiner, David Orbison, Michael Seymour and Connie Klauck.

Visitors: Mark Weil, Jimmy Kohl, Toni Autry

Mrs. Autry suggested that the Council contact the Historical Society for East Beaver (part of the Lincoln Highway) to see if there would be any assistance to be given for repairs. Mayor Orbison reported that he contacted them last year and never received a response.

Minutes: The Minutes from the May 20, 2024 meeting were reviewed. A Motion was made by Curtis Reiner; seconded by Joel Kaminski; to accept the minutes. No discussion held; all were in favor – motion passed.

Treasurer's Report: Connie Klauck read aloud the Treasurer's Report to Council. A Motion was made by Joel Kaminski; seconded by Greg Joyce; to approve the Treasurer's Reports. No discussion held; all were in favor – motion passed.

Wage and Real Estate Tax: For the month of May 2024, \$4335.78 was collected for Wage Tax and \$2354.92 for Real Estate and Per Capita.

Reading and Approval of Bills: Connie Klauck read aloud the bills for May 2024 while the members of Council followed along. A Motion was made by Curtis Reiner; seconded by Travis Hartzog; to pay the bills. No discussion held; all were in favor – motion passed.

Police Report: None.

Fire Report: Jim Kohl attended the Meeting and reported that they responded to 1 fire call in Glenfield Borough in the month of May.

Solicitor's Report: Solicitor Seymour had no report.

Correspondence: Ms. Klauck reported that the 2023 audit is in progress.

Budget and Finance: None.

Grants Committee: None.

Public Safety: President Carmody reported that the multi-municipal Emergency Preparedness group is still meeting monthly. They are currently composing a data base of what kind of equipment each Borough has to offer in the case of an emergency.

Building and Ordinance: None.

Streets and Sewers: After discussion, Curtis Reiner volunteered to contact Norfolk Southern about the steel rails and rocks left laying along the road to the Park.

Parks and Recreation Committee: Travis Hartzog is continuing to look for someone to complete the fencing around the Park. Ms. Klauck will forward the pricing from Allegheny Fence to him.

Old Business: Megan Larkin reported that she was unable to get anyone to quote mowing the strip of grass along Dawson Avenue.

The Council Meeting entered into an Executive Session from 7:25 p.m. to 7:49 p.m. to discuss the litigation for 247 Dawson Avenue.

A Motion was made by Travis Hartzog; seconded by Curtis Reiner; to authorize Michael Seymour to continue to work with Mr. McLinden's defense attorney and to give Paul Carmody full authority to attend the hearing on behalf of Glenfield Borough Council with full authority to authorize the solicitor in all matters of the hearing including withdrawing charges and settlement. No discussion held; all were in favor – motion passed.

New Business: Mr. Joyce asked if any permission was given from the Borough for placing a structure in the Borough right-of way. He has a list of questions that he will email the Borough.

Adjournment: A Motion was made by Curtis Reiner; seconded by Travis Hartzog; to adjourn the Council Meeting. The Motion carried unanimously; meeting adjourned at 7:51 p.m.
